BEING 1.659 acres situated in the A. E. Gossett Survey, Abstract 423, Houston County, Texas, being all of a called 1.65 acres as recorded in Instrument #1103297 of the Official Records of Houston County, Texas (ORHCT). Same being located at 1104 East Houston Ave. Crockett, Texas. Said 1.659 acres being more particularly described by Metes and Bounds as follows:

BEGINNING at an existing ½" iron pipe found marking the Northeast corner of this 1.659 acres, the Northwest corner of a called 2.00 acres as recorded in Volume 1113 Page 758 of the ORHCT and in the South line of a called 0.717 of an acre as recorded in Instrument #1703363 of the ORHCT;

THENCE with the West line of said called 2.00 acres South 00°14'54" West a distance of 389.90 feet to an existing 3/8" iron rod found marking the Southwest corner of same and in the North margin of said East Houston Street:

THENCE with the North margin of said East Houston Street South 65°39'22" West a distance of 204.92 feet to an existing ½" iron pipe found in same and being in the East line of a called 0.560 of an acre as recorded in Instrument #1903548 of the ORHCT, said point having an existing 3/8" iron rod found for reference South 08°42'31" East a distance of 6.04 feet;

THENCE with the East line of said called 0.560 of an acre North 00°12'17" West a distance of 227.76 feet to an existing 1" iron pipe found marking the Northeast corner of same and being the Southeast corner of a called 0.653 of an acre as recorded in Instrument #1800568 of the ORHCT;

THENCE with the East line of said called 0.653 of an acre North 00°50'49" East a distance of 153.85 feet to an existing '4" iron pipe found in same and being the Southwest corner of said called 0.717 of an acre;

THENCE with the South line of said called 0.717 of an acre North 63°36'18" East a distance of 208.69 feet to the Place of Beginning and containing 1.659 acres of land.

NOTE: Bearings are based on compass observations taken this date.
