## Metes & Bounds Property Description

A tract of land containing 0.0729 Acre (3,174 Square Feet), being Lot 33 out of Unrestricted Reserve "A", Meadows On The Mews according to the map or plat thereof recorded in Volume 301, Page 19 of the Map Records of Harris County, Texas (M.R.H.C.T.), being the same tract recorded in the name Cang T. Dinh and Mylien T. Truong, husband and wife, under Harris County Clerk's File (H.C.C.F.) No. RP-2017-234442, being more particularly described by metes and bounds as follows: (Bearings based on said Volume 301, Page 19 of the Map Records of Harris County, Texas)

COMMENCING at a point on the east right-of-way line of Ashford Park Drive (80 Feet wide), being the northwest corner of this tract;

THENCE, NORTH 87° 19' 56" EAST, with the south line of Meadow on Ashford as recorded in Volume 312, Page 128 of the M.R.H.C.T., a distance of 252.72 Feet to a fence post at the northwest corner and POINT OF BEGINNING of this tract;

THENCE, NORTH 87° 19' 56" EAST, continuing with said south line of Meadow on Ashford, a distance of 48.95 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the northeast corner of this tract;

THENCE, SOUTH 02° 32' 00" EAST, with a west line of the remainder of the aforementioned Unrestricted Reserve "A", a distance of 64.85 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the southeast corner of this tract;

THENCE, SOUTH 87° 19' 56" WEST, with the north line of a tract recorded in the name of PKY Capital Management, LLC. under H.C.C.F. No. 20130085522 and the north line of a common area, a distance of 48.95 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the southwest corner of this tract;

THENCE, NORTH 02° 32' 00" WEST, with the east line of a tract recorded in the name of Mansour Shirvani and Behnaz Sanati, husband and wife under H.C.C.F. No. 20130482623, through a party wall, a distance of 64.85 Feet to the POINT OF BEGINNING and containing 0.0729 Acre of land.
