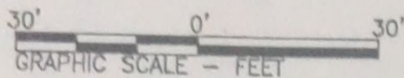


GENERAL NOTES

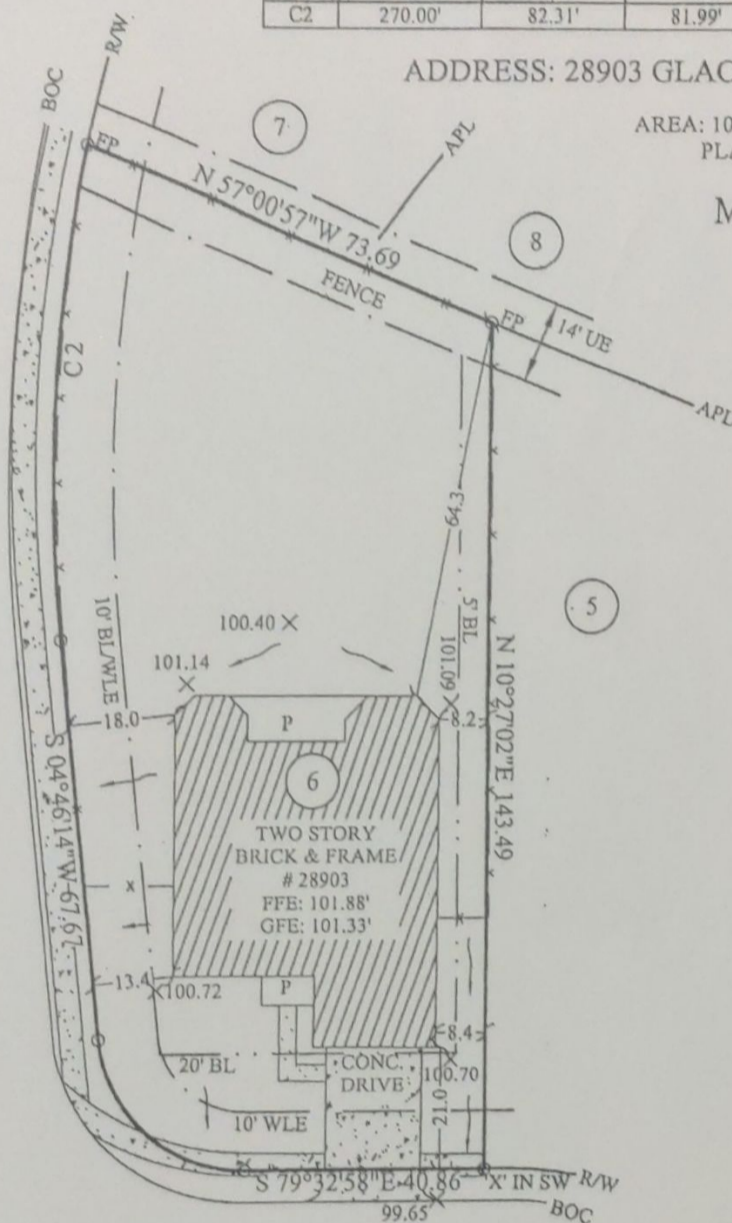

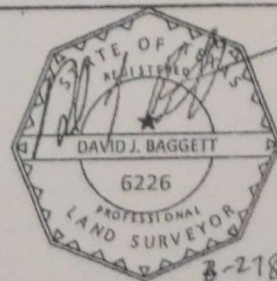
