ABOUT RAINWATER COLLECTION

We get our water direct from the source. It stays here and remains as nature intended. It's the ultimate purest form of water.

When we built a prior home in the Georgetown Texas area, we were faced with drilling a 900 foot deep well with questionable water quality. We started looking for options. We had wells before and know of the uncertainties that come with them. A friend suggested we look into rainwater collection and the more we looked into it, the more we wanted it. We decided to get our water from above ground rather than below. Our water isn't run-off from area pastures, roadways, streams or lakes. It hasn't run through underground caverns or aquifers collecting minerals or sulfur smells. Our pump isn't hundreds of feet below ground or subject to lowering water tables as more consumption occurs in high-growth areas. Our entire system is right here, easily accessible.

If you've ever maintained a water softener you can maintain this system. But you will no longer need a softener. Our water has zero hardness. It has no sediment, so our water heater has no deposits. The glasses and dishes from the dishwasher look brand new after years of use. You have no chlorine or chemicals added to correct the contaminants of municipal water. In the summer, we've found we use less hot water in the shower since it's already warmed. Our plants thrive on pure rainwater every time we water.

Simplified, the clouds pour the water onto our roof (collection surface) where it falls into the gutters, then travels in pvc pipe underground and enters the tanks. When the faucet is opened, the pump comes on and sends the water through two filters. The first filter is a 10 micron sediment filter to remove organic materials that collect in the tank. The second filter is a smaller 5 micron charcoal block filter to further reduce particles and remove any odors from the water. It then passes through an ultraviolet light to kill bacteria. You can periodically test the water at water test sites to ensure the water is safe.

The maintenance is very simple. Change the first filter once a month. The second filter needs changing about every three months. And the UV light should be changed once a year even though it hasn't burned out. Its effectiveness will diminish after a year. Total cost if you buy several filters (16) at a time and a UV light can run about \$150 a year, a monthly bill of \$12.50. The largest expense is really concentrated during the initial equipment and installation period. We've done all that. And if the pump needs service, it takes a novice about 15 minutes to change it since it's located in the shed in the backyard. There are other tricks to learn to keep the collected water as pure as possible, but in short time you'll see it's easy and you'll agree the water is the best you've ever had.

We can go literally months without rainfall using the 7500 gallons of storage. With the amount of collection surface we have (4416 sq ft), every half inch of rain collects about 2400 gallons of water.

Typically, we remain near full during the winter months. During the summer when rainfall is sometimes scarce, the level falls and recovers as fall begins. If your usage were to increase to where the level falls too low, installing additional tanks would solve the problem. Here we've probably had more water overflow from the tanks than we've actually used.

A good source, located in Dripping Springs, who coached us in the construction of our system, is Richard Heinichen. He started a business there called *Tank Town* that sells everything you may ever need. (We buy a years' worth of filters through Amazon for the best price.) He has a good video on youtube. Look up "**Cloud Juice (rainwater collection in Dripping Springs)**" there. It's a brief summary of the reasons this system works so well. A source to learn more detailed technical information would be www.twdb.texas.gov. This site has the most information in any one place. Once you've read all that's there, you'll be very knowledgeable of the entire system.

If the worst ever occurred and the water ran out or went very low, there are companies that haul potable water that can add more water into the tank. They haul in around 2000 gallons in one truck. Here in this location, with three people living here at times, we've had no problem. When others are without water or have "boil water notices", your system is pure water. It's different, but we believe it's also better.
