RESOLUTION ADOPTING ASSIGNED PARKING SPACES

(the "Association"), a Texas Non-Profit Corporation, pursuant to Chapter 22 of the Texas Business Organizations Code and §82.102 of the Texas Uniform Condominium Act ("TUCA"), adopt the following resolution at a duly called board meeting:

WHEREAS, the Association is responsible for the governance and maintenance of Promenade Place Condominiums as described in the Promenade Place Declaration of Condominium recorded on December 8, 2011, under Clerk's File No. 20110513262 in the Official Public Records of Harris County, Texas, and under Film Code No. 211206 in the Condominium Records of Harris County, Texas, including all amendments thereto; and

WHEREAS, the Association exists pursuant to state law and its governing documents; and

WHEREAS, the Association is authorized to establish, make and enforce compliance with such reasonable rules as may be necessary for the operation, use and occupancy of the Condominiums, with the right to amend same from time to time, pursuant to state law and its Governing Documents; and

WHEREAS, Section 1.3. Parking Spaces, of the Declaration states as follows:

"...The Association may from time to time, at any time, assign or lease such Parking Spaces to any of the Owners or otherwise use such Parking Spaces, all in a manner to be determined by the Board. In the event that Parking Spaces are assigned by the Association to an Owner of a Residence Unit, then any such assigned Parking Spaces shall be Limited Common Elements for the exclusive use of the Owner of the Residence Unit to which such Parking Spaces are assigned...."; and

WHEREAS, Section 10.4. Amendments of Rules and Regulations, of the Declaration states as follows:

"The Rules and Regulations may be amended from time to time by the Board. Each Owner, by accepting conveyance of a Residence Unit agrees to comply with and abide by the Rules and Regulations as the same may be amended from time to time"; and

WHEREAS, as requested by a majority of the Owners and approved by the Board, the Board desires to adopt an Assigned Parking List; and

WHEREAS, for the benefit and protection of the Association, the Owners, and the residents, the Board adopts the Assigned Parking List attached hereto as <u>Exhibit "A"</u> and incorporated herein for all purposes.

NOW, THEREFORE, BE IT RESOLVED, that upon careful consideration and deliberation,


