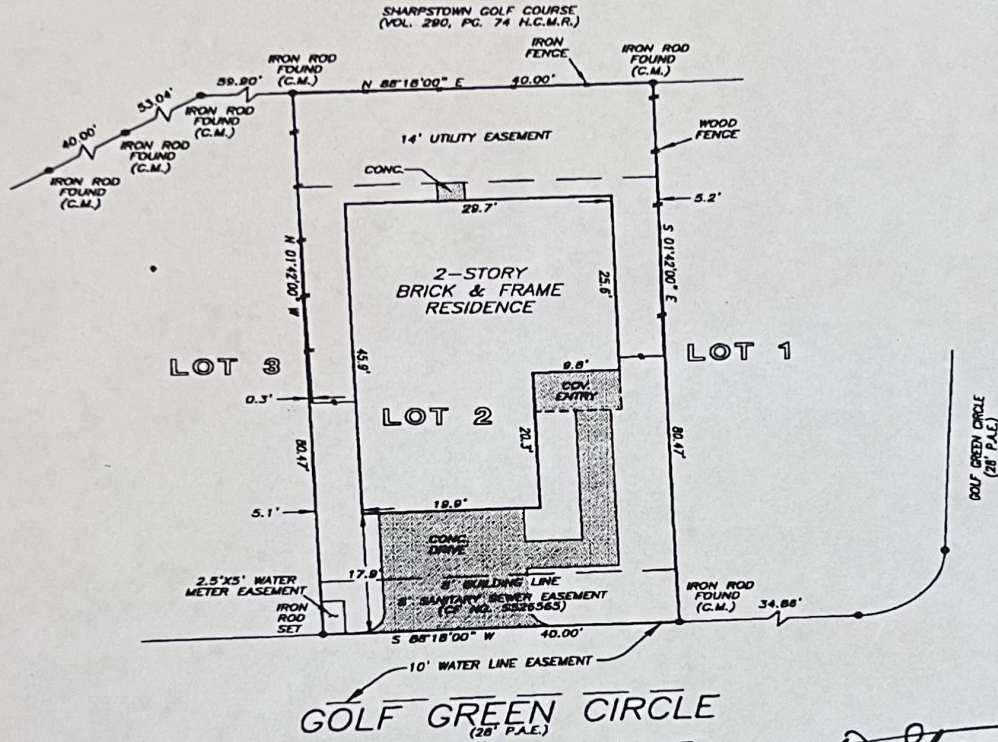


LOT 2, BLOCK 1 GOLF GREEN GARDEN HOMES, SECTION 1
